Understanding Student Needs

WHEREAS, With the vast number of states participating, the Center for Disease Control's Youth Risk Behavior Survey is the largest and most comprehensive method to understand the needs of children and youth in the United States; and

WHEREAS, Participation in this survey provides extensive anonymized data regarding children, youth, and families. This enables legislators, policy makers, education planners, social service workers, advocates, stakeholders, and others to inform their work and better meet student needs effectively; and

WHEREAS, Florida abandoned statistical collection efforts via the Youth Risk Behavior Survey in 2022 and substituted less comprehensive forms, thereby hampering educational and social programs' abilities to meet students' needs; and

THEREFORE BE IT

RESOLVED, Florida PTA urges the legislature, policy makers, and stakeholders to mandate the collection of data via the Youth Risk Behavior Survey and support the collection of data within their districts.

Rationale

Often, the best way to find out information is to ask questions and listen to their answers. The Youth Risk Behavior Survey asks necessary questions so we can learn through their anonymized answers what teens are doing and feeling. This gives us insight as to their physical and mental health and their participation in risky behaviors that can lead to death. An analysis of the reliable Youth Risk Behavior Survey results is crucial to improve Florida's support of students and families within the health, social service, and education systems. This knowledge provides a necessary foundation for programs to meet students' needs and address changing trends.

As of 2022, Florida discontinued participation in the comprehensive, well-established Youth Risk Behavior Survey. Without this key information, Florida's health, social service, and education systems will be unaware of students' critical risky behaviors and experiences. Thus, students' needs will be unmet in Florida.

As child advocates, we need the most comprehensive and accurate data to help our students. We need Florida to participate in the Youth Risk Behavior Survey.
